About United Nations Global Compact

Launched in 2000 as a special initiative of the UN Secretary-General, the United Nations (UN) Global Compact provides a framework for developing a more sustainable and responsible business.

Today, the UN Global Compact is the largest corporate sustainability initiative in the world, and it is a call to companies everywhere to align their operations and strategies to ten universally-accepted principles in the areas of human rights, labour, environment, and anti-corruption.

The United Nations' Sustainable Development Goals

The 2030 Agenda for Sustainable Development, adopted by all United Nations Member States in 2015, provides a shared blueprint for peace and prosperity for people and the planet, now and into the future.

At its core are the 17 Sustainable Development Goals (SDGs), which present an urgent call for action by all countries - developed and emerging - in a global partnership. They recognise that ending poverty and other deprivations must go hand-in-hand with strategies that improve health and education, reduce inequality, and spur economic growth – all while tackling climate change and working to preserve our oceans and forests.

We believe businesses play a key role in advancing the SDGs. Responsible business practices, combined with collaboration and innovation, can bring about powerful changes in societies and markets.



THE TEN PRINCIPLES OF THE UNITED NATIONS GLOBAL COMPACT

Sustainability begins with a principles-based approach to doing business. The Ten Principles lay the foundation for any company seeking to advance the SDGs.

HUMAN RIGHTS

- 1 Businesses should support and respect the protection of internationally proclaimed human rights; and
- 2 make sure that they are not complicit in human rights abuses.

LABOUR

- 3 Businesses should uphold the freedom of association and the effective recognition of the right to collective bargaining;
- 4 the elimination of all forms of forced and compulsory labour
- 5 the effective abolition of child labour; and
- 6 the elimination of discrimination in respect of employment and occupation.

ENVIRONMENT

- 7 Businesses should support a precautionary approach to environmental challenges;
- 8 undertake initiatives to promote greater environmental responsibility; and
- 9 encourage the development and diffusion of environmentally friendly technologies.

ANTI-CORRUPTION

- 10 Businesses should work against corruption in all its forms, including extortion and bribery.

The Ten Principles of the United Nations Global Compact are derived from: the Universal Declaration of Human Rights, the International Labour Organization's Declaration on Fundamental Principles and Rights at Work, the Rio Declaration on Environment and Development, and the United Nations Convention Against Corruption.

In 2021, we have upskilled over 150 professionals through the Advanced Certificate for Sustainability and Sustainable Businesses, conducted in collaboration with Singapore Management University Academy.

With 81% of companies surveyed attributing their progress on sustainability to their participation in the UN Global Compact¹, we are heartened, and committed to creating even more value for you to further accelerate your sustainability journey. 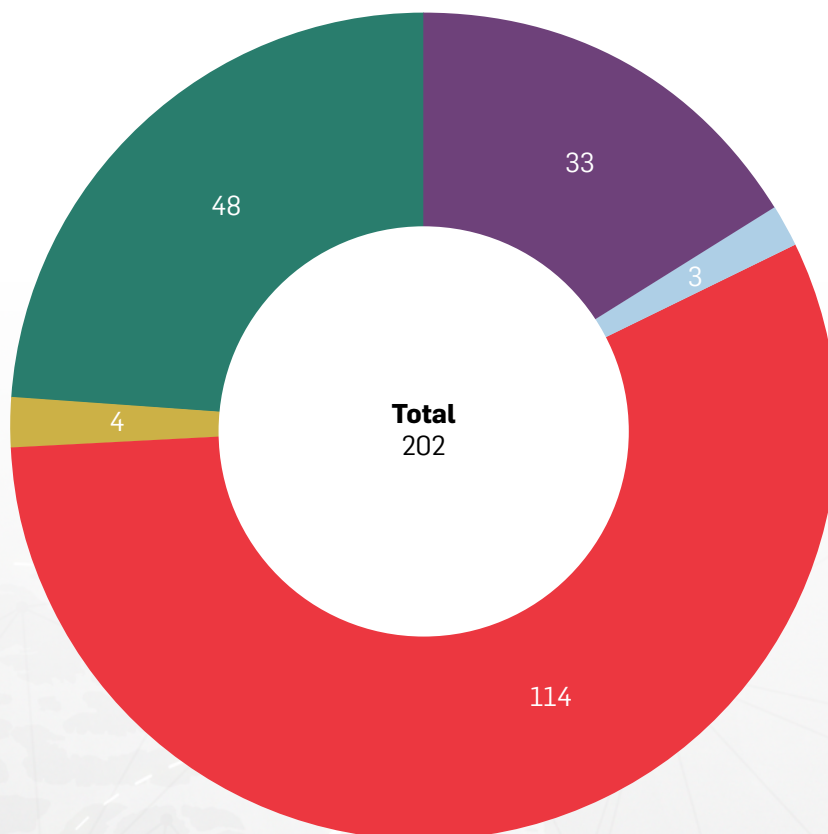

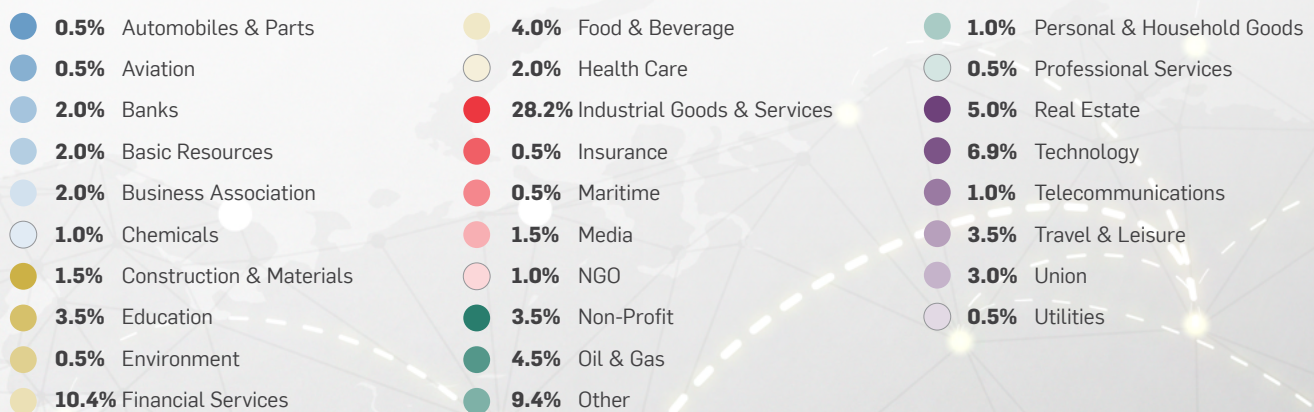
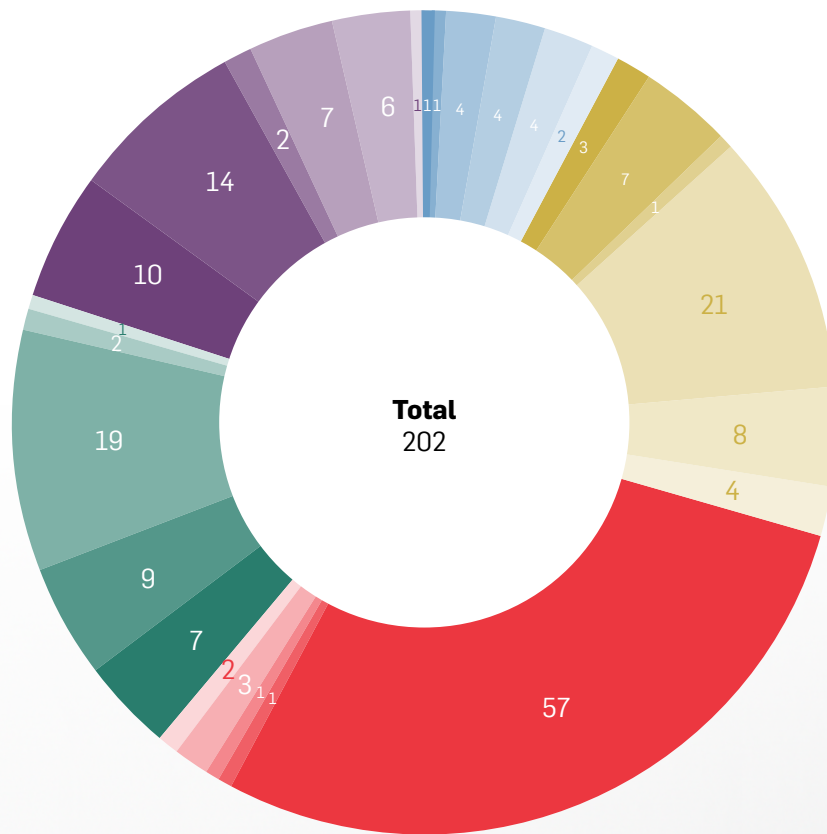

- Business leadership, acting in concert, will be the key driver charting the path for these changes.

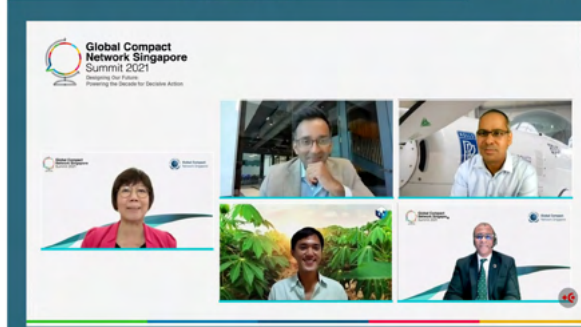

Reservoir, depending on the prevailing weather conditions, thus strengthening Singapore's water supply resilience. Seamlessly integrated with the surrounding greenery, KMEDP features nearly 20,000 square metres of open green rooftop space for community activity and recreation.

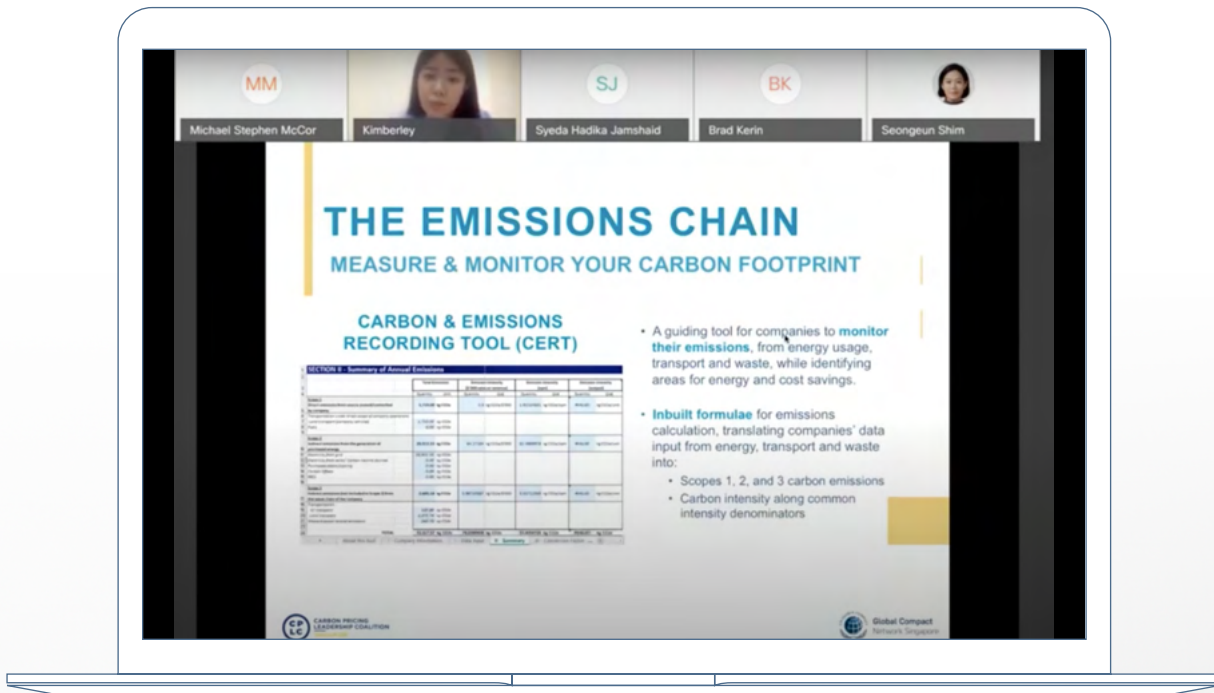

In 2021, CPLC Singapore organised 12 carbon management training workshops, upskilling 197 companies and 333 participants. The sessions provided beginners with insights on the business case for decarbonisation, strategies for identifying low-hanging fruit to reduce emissions and a basic understanding of carbon footprint calculations in order to reduce operational costs.

Participants were also introduced to the Carbon & Emissions Recording Tool (CERT), developed with input from the National Environment Agency (NEA).

What more do you think your industry could be doing to adopt low-carbon solutions?

After taking our first steps in decarbonisation via LowCarbonSG, we are now planning to go a step further by analysing and pushing for ways to monitor and control our carbon emissions from the equipment, machinery and vehicles that we deploy. If our clients can prioritise companies that seriously embark on decarbonisation efforts, it would catalyse overall efforts.

How has using CERT helped you in your daily business operations?

CERT is a simple way for us to tabulate our consumption data and translate it into emissions data. It has been very helpful to us in monitoring and controlling our carbon footprint.

What advice would you give to SMEs looking to kickstart their carbon management efforts?

There is always an apprehension surrounding decarbonisation: from additional work created to difficulties in monitoring. But with the help of CPLC Singapore, taking the first step to monitor your emissions is not as difficult as it seems.

LowCarbonSG

LowCarbonSG is a capability-building programme to enable local businesses in Singapore to start monitoring and, where possible, reduce their carbon emissions.

The 18-month programme is helmed by Carbon Pricing Leadership Coalition (CPLC) Singapore, the decarbonisation arm of GCNS and supported by the National Environment Agency (NEA) and Enterprise Singapore (ESG).

In support of the Singapore Green Plan 2030, LowCarbonSG intends to develop in businesses the habit of measuring, tracking and reducing their carbon footprints digitally through capability-building programmes. Companies that successfully measure and monitor their carbon footprints will be issued a LowCarbonSG Participant Logo.

The initiative was announced by Ms Grace Fu, Minister for Sustainability and the Environment at the GCNS Virtual Summit on 26 October 2021.



CPLC Singapore is grateful for multi-sectoral support for LowCarbonSG, ranging from government agencies such as the Maritime and Port Authority of Singapore (MPA) and Sentosa Development Corporation (SDC), to industry associations such as the Association of Singapore Marine Industries (ASMI), Association of Process Industry (ASPRI), the Singapore Shipping Association (SSA), and Innovate 360.

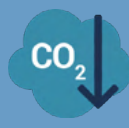
To date, CPLC Singapore has engaged 197 companies and upskilled 333 staff in emissions awareness and knowledge.

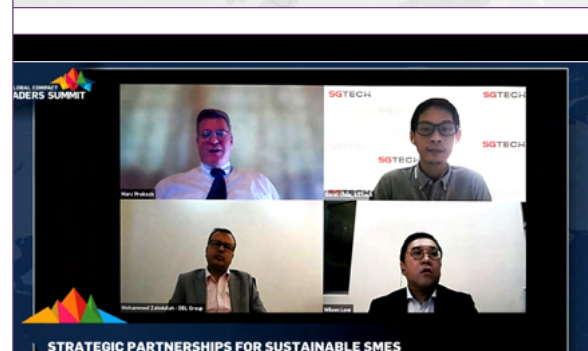
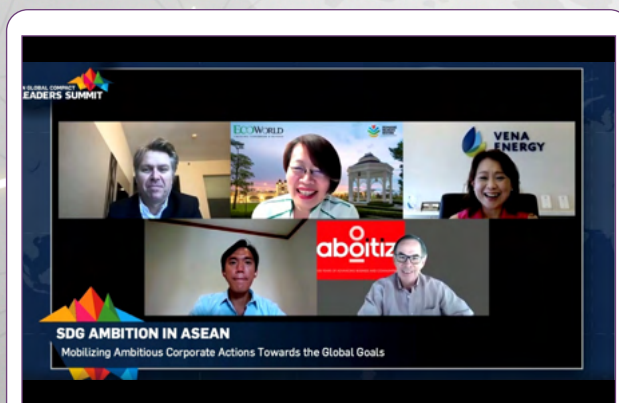

How do you see sustainable finance shaping Singapore’s sustainability agenda over the next 5-10 years?

As a global financial centre, Singapore has a key role to play in growing sustainable financing as an asset class.

Key to this will be developing a clear taxonomy and verification processes, as well as suitable products.

What measures do you think should be implemented to facilitate access for small and mid sized companies to sustainable finance?

We face two key challenges in the SME sector. First, a lack of robust ESG data. And second, the relatively small ESG capital needs for each individual SME. Both drive the need for product innovation and the harnessing of technology, such as blockchain, to scale capital allocations to the SME sector as a whole.

What advice would you give to companies looking to tap on sustainable financing?

It is critical to not look at sustainable finance simply as a source of capital, but

as an integral part of one’s purpose and strategy. Well-designed sustainable finance solutions incentivise and support change within an organization, which helps to not only future-proof its capital structure, but also its entire business model.

What is your future vision for revolutionising your business industry, especially with respect to environmental and social impact?

All our sustainability challenges can only be tackled collectively. We need to rewire our economies through strong ecosystems. At DBS, we are committed to create impact at scale by not only empowering our own clients to transition, but by also creating strong ecosystems leveraging technology. We co-founded Climate Impact X, a global carbon market that incorporates satellite technology to provide for transparent impact, a world’s first.

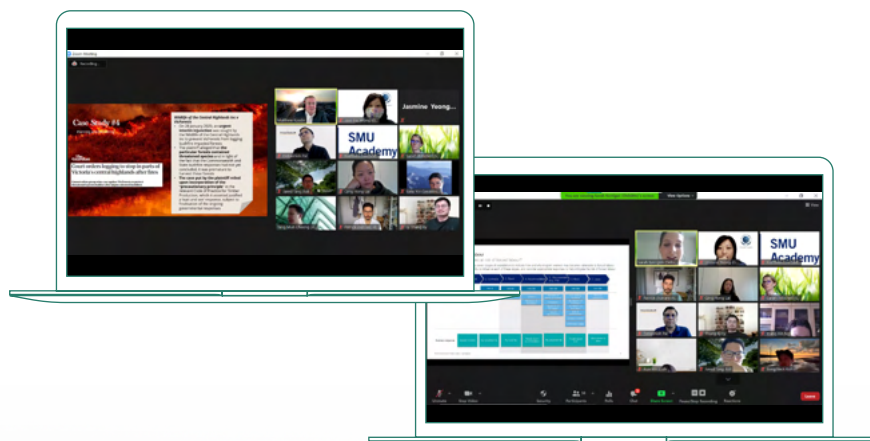

In your opinion, what is the most impactful action that a company in your industry can take to drive decisive action for the SDGs?

The best businesses are vehicles for deeper value creation. Aligning with the SDG framework, inclusive sustainable

development, advocating responsible tourism for economic growth, partnering with local communities within and across sectors, and seeking solutions to local challenges are just some ways a company can create positive impact.

What can incentivise stakeholders in your industry to be more sustainable?

The tourism industry is inherently linked to natural and cultural heritage, and is particularly vulnerable to climate change. Consequently, travel and tourism stakeholders are responsible for safeguarding the environment and the communities where they operate. This incentivises stewardship and long-term sustainable management of destinations, people and the environment.

How do you think businesses can go above and beyond the regulatory requirements of corporate sustainability?

Businesses should leverage their resources, manpower and connections within the communities where they

operate to serve the society, going beyond the precautionary approach to proactively listen to and address the needs of all stakeholders, not just shareholders.

What inspired you to pursue creating a sustainable impact in your industry?

For Banyan Tree Group, it comes down to a single word: Purpose. Our sustainability stewardship of natural and cultural heritage, under our founding ethos of "Embracing the Environment, Empowering People", has provided us a compass to serve as a vehicle for greater good.

This started over 30 years ago with our Laguna Phuket in Thailand, Asia's first integrated destination, which was rehabilitated and transformed from an abandoned tin mine. 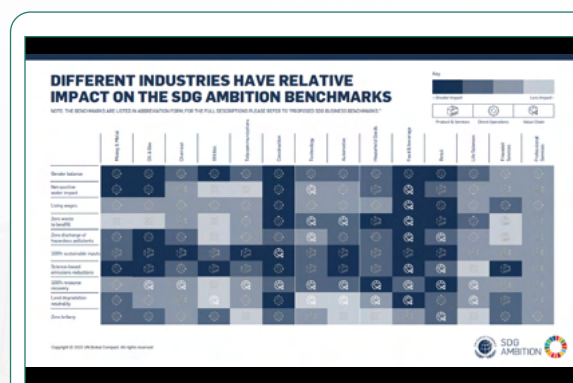
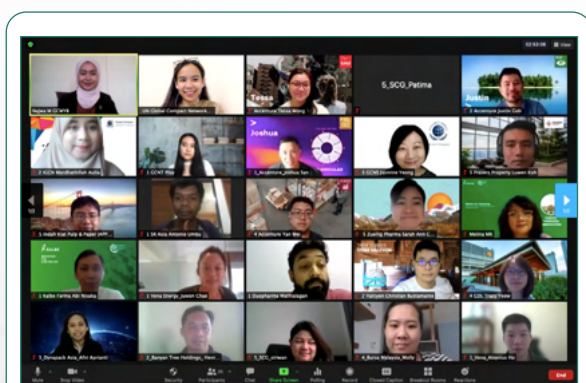
SDG Ambition Accelerator

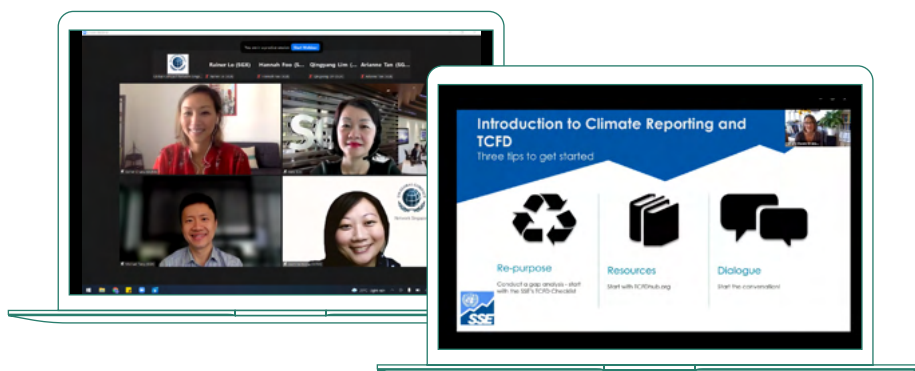

In August 2021, Singapore Exchange Regulation proposed a roadmap for climate-related disclosures to be made mandatory in issuers' sustainability reports in response to increasing demand for such information.

The roadmap was shared in a webinar organised by Global Compact Network Singapore.

During the session, Ms Tiffany Grabski, Deputy Coordinator, UN Sustainable Stock Exchanges, gave an introduction to the Taskforce for Climate-related Financial Disclosures (TCFD). Mr Michael Tang, Head of Listing Policy and Product Admission, Singapore Exchange Regulation shared further on the proposed requirements in climate-related disclosures and engaged in a lively question and answer session with participants.

How do you see sustainable finance shaping Singapore's sustainability agenda over the next 5-10 years?

With 2030 decarbonisation goals looming, Singapore will build on strong foundations in green finance:

First, as an established financial centre in the region and globally, we can bring the Asian financing perspectives to international climate finance conversations. Second, we are as a nation advancing in capacity building, e.g. TCFD training by SGX and partners, and sustainable finance courses launched by our universities. Third, we are anchoring the know-how for mobilising capital towards climate action and the transition in the wider economy in the region.

What measures do you think should be implemented to facilitate access for small and mid sized companies to sustainable finance?

SMEs make up the bulk of companies in the region, and a comprehensive framework covering capacity building, guidance, initiatives facilitating the provision of ESG data to access sustainable finance, and grant schemes would be helpful. Examples include Enterprise SG's Enterprise Sustainability Programme, making SGD 180 million available to support

SMEs' sustainability initiatives, and MAS' range of grant schemes to make sustainable financing more accessible; such as the Green and Sustainable Bond Grant Schemes, and the Green and Sustainability-Linked Loan Grant Schemes.

What inspired you to pursue creating a sustainable impact in your industry?

If we are to protect our planet and people, those of us in business will also have to take the lead. At SGX, we can enable systemic changes, spotlight best practices, and empower business owners, companies and investors via practical solutions. We have and will continue to engage and partner with, listen and learn from all our stakeholders. As an individual driven by purpose and positive impact, I am innately driven to tackle big hairy sustainable goals which at times is daunting, so we need to efficiently collaborate, break down biggest challenges into measurable and meaningful pillars and milestones.

CDL-GCNS Young SDG Leaders Award

In its 11th edition, the CDL-GCNS Young SDG Leaders Award (YSDGLA) is a business case competition that provides youths with a platform to implement the Sustainable Development Goals (SDGs) within real-life corporate scenarios.

Jointly organised by City Developments Limited (CDL) and GCNS, the YSDGLA seeks to:

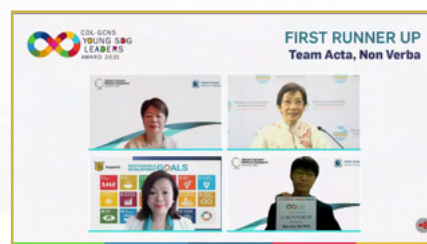
- Educate and empower young leaders to integrate the SDGs into business strategies and operations

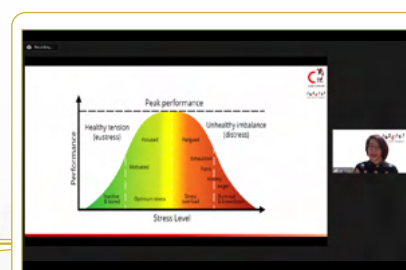
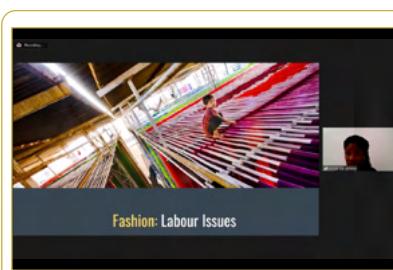

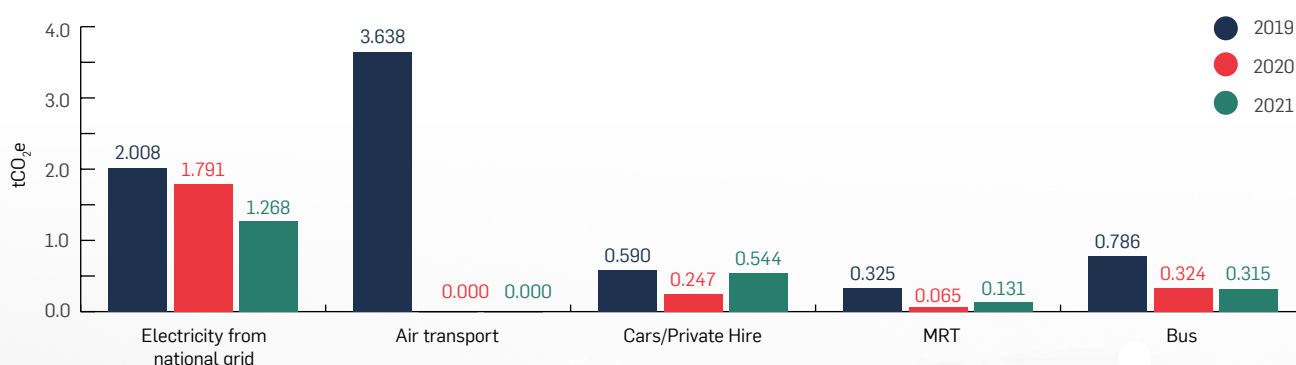
Operating Responsibly

Our Emissions

In line with government regulations in response to COVID-19, GCNS continued with work-from-home arrangements while continuing to expand product and service offerings to the local business community.

While the complete reduction of air travel and continued work-from-home arrangements maintained GCNS' emissions at a reduced level compared to 2019, the increase in employee headcount led to an increase in emissions attributed to employee commuting.

Notes on GCNS' GHG Emissions:

Electricity forms the largest part of GCNS' energy consumption which we classify as Scope 2 emissions. This is calculated from the organisation's area-based cost-share of utility bills and invoices of the floor it operates from. Emission factors for electricity and fuel mix figures for electricity generation are guided by Energy Market Authority's Singapore Energy Statistics. The calculations for the current financial year utilises Energy Market Authority fuel mix for 2020 which comprises natural gas (95.8%), and other sources such as municipal waste, biomass and solar (2.8%), coal (1.0%) and petroleum products (0.4%).

GCNS has chosen to report on the emissions impact of land transport of staff to commute and conduct out-of-office business activities and air transport when relevant as these are material to the company's nature of work and consist of the largest contributors in our operations. These emissions are classified as Scope 3. Public transportation assumptions are based on figures provided by SMRT Corporation's Annual Report 2016. Land distance-based emission factors for passenger vehicles are guided by the Land Transport Authority publication in 2018 on the Vehicular Emissions Scheme (Assumptions: (1) General passenger cars fall in Band B, (2) Electric vehicles fall in Band A1). Our People

Our people are GCNS' most valuable asset: they are essential to our mission to advance the stewardship of sustainable business practices.

Good Employment Practices

GCNS operates in accordance with the Ministry of Manpower's (MOM) Employment Act. Additionally, GCNS ensures that employment practices are aligned with the tripartite guidelines set by MOM, National Trades Union Congress (NTUC) and the Tripartite Alliance for Fair and Progressive Employment Practices (TAFEP).

Employee Well-Being

GCNS strives to keep its employees safe, engaged and valued.

Amid COVID-19, GCNS continued operating in split teams in alignment with government recommendations. Ambassadors are appointed from each team to ensure adherence to safe management and distancing measures. Bridging connections while apart - care packs, a series of health and well-being webinars by WorkPLAYce by Prudential were organised for the team.

Mindful that it could be daunting for new hires to commence work from home, GCNS created processes to make all new team members feel welcome. Initiatives include virtual onboarding as well as virtual coffee chats with all business units.

Despite the restrictions that COVID-19 brought about, GCNS managed to convene for its annual staff retreat to reflect as a team, while discussing future plans and strategies. The retreat included a terrarium-making workshop, as well as team learning sessions on systems thinking, and change management.

Supporting Professional Development

As a champion of organisational learning, GCNS encourages all employees to continually upskill themselves through webinars and courses. All employees are also encouraged to build on their sustainability knowledge via the United Nations Global Compact Academy's on-demand sustainability courses.

In 2021, GCNS is proud to have supported 23.5% of its workforce through professional development programmes in the areas of decarbonisation, project management and human resources.

Additionally, GCNS participates in government programmes that promote skill conversion for a career transition into sustainability. Examples include the SGUnited Traineeship Programme, as well as the Employment and Employability Institute's (e2i) Professional Conversion Programme to help new team members ease into their new roles via structured on-the-job training.

Our Governance

Global Compact Network Singapore is an Institution of a Public Character (IPC) and is governed by the Charities Act.

Anti-Corruption Policies

Conflict of Interest Policy

GCNS has a Conflict of Interest policy that all staff and Management Committee members are required to comply prior to joining the organisation. As a registered charity with IPC status, GCNS has an obligation to act in the best interests of the Charity.

Sound Internal Controls

Clear operating procedures are key to minimise uncertainties when fulfilling duties of care and prudence. GCNS has Standard Operating Procedures in place around financial expenditures, sponsorships, and approval mechanisms.

Data Protection

GCNS strives to safeguard the personal data of any person whose data it processes, and has put in place a data protection policy in consultation with external counsel Bird & Bird ATMD. This includes, but is not limited to, the personal data of employees, members and event attendees.

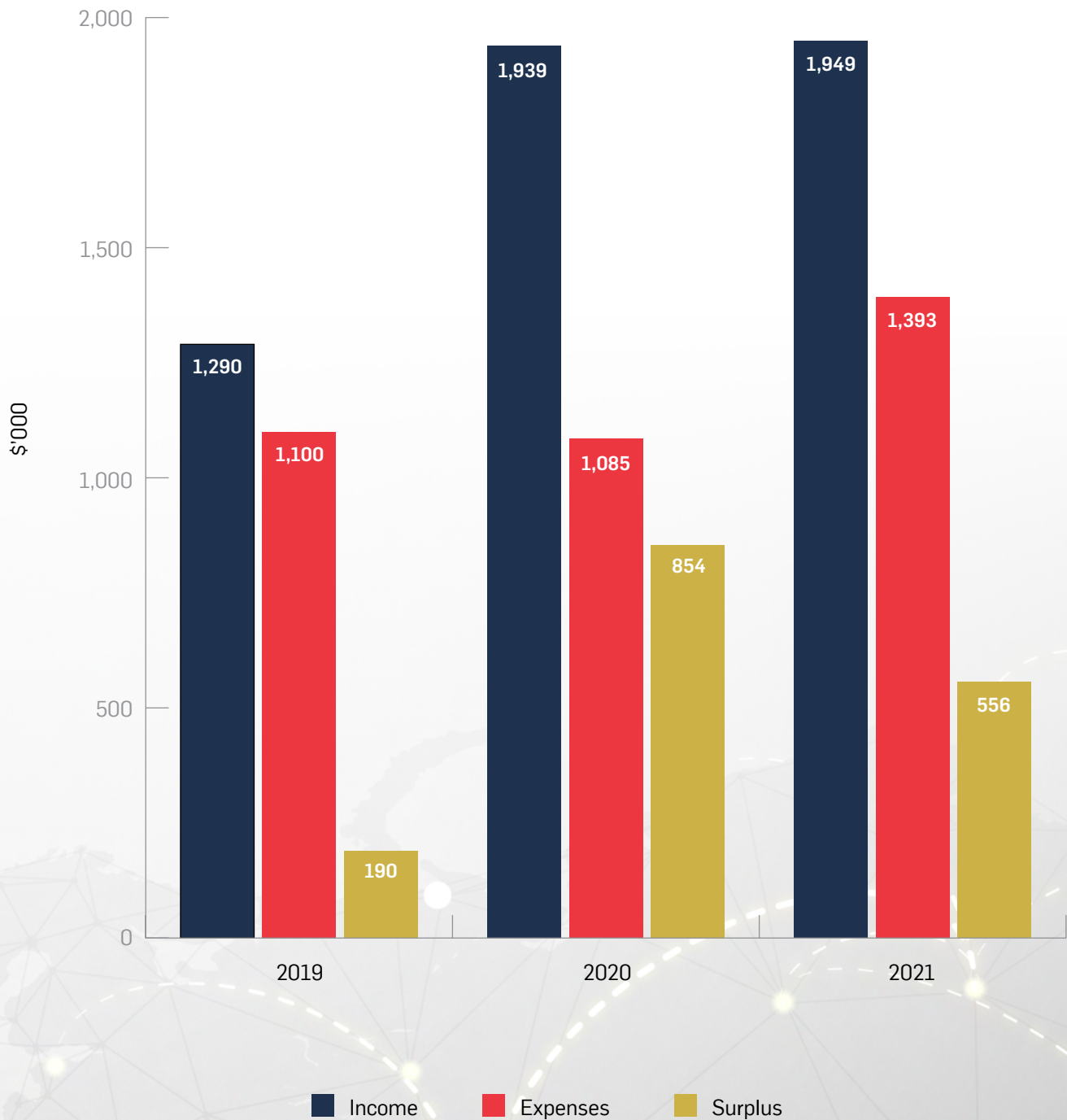
